The Government of the Republic of Cabo Verde has received financing from the World Bank toward the cost of the **Resilient Tourism and Blue Economy Development in Cabo Verde Project** and intends to apply part of the proceeds toward payments under the contract for **Rehabilitation of Ponte Canal in Santo Antão**. For this contract, the Borrower shall process the payments using the Direct Payment disbursement method, as defined in the World Bank's Disbursement Guidelines for Investment Project Financing.
2. The implementing agency, **Unidade de Gestão de Projectos Especiais (UGPE)**, now invites sealed Bids from eligible Bidders for **Rehabilitation of Ponte Canal in Santo Antão**. The Ponte Canal is a hydraulic aqueduct. It is a mixed structure executed in stone masonry and reinforced concrete. It is located on the island of Santo Antão in Cape Verde and its design and construction was the responsibility of the *Brigadas Técnicas de Estudos e Trabalhos Hidráulicos (B.T.E.T.H.)*.
3. Bidding will be conducted through national competitive procurement using Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers", dated July 2016 and revised in November 2017, August 2018 and November 2020 ("Procurement Regulations"), and is open to all eligible Bidders as defined in the Procurement Regulations.
4. Interested eligible Bidders may obtain further information from Unidade de Gestão de Projectos Especiais (UGPE) and inspect the bidding document during office hours from 8 a.m. until 4 p.m. (local time), during working days, at the address given below. In addition, please refer to paragraphs 3.14, 3.15 and 3.17 setting forth the World Bank's policy on conflict of interest.
5. The Bidding document in English may be purchased by interested eligible Bidders upon the submission of a written application to the address below.
6. Bids must be delivered to the address below on or before **January 23, 2023 at 3:00 pm**. Electronic Bidding will be permitted. Late Bids will be rejected. Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below by **January 23, 2023 at 3:30 pm (CV time)**.
