Assignment Title: Recruitment of an Engineer Consultant (Owner's Engineer) for the control and supervision of the works and supplies in the scope of the sub-component 1a: small-scale renewable energy generation facilities and power evacuation lines of the project

The Government of Cabo Verde is negotiating a financing in the amount of US\$16.5 million equivalent from the World Bank toward the cost of the Cabo Verde Renewable Energy and Improved Utility Performance Project, and it intends to apply part of the proceeds for consulting services. The objective of the Project is to increase renewable energy generation and improve the performance of the electricity utility in Cabo Verde by leveraging private finance.
- 2. The consulting Services ("the Services") includes recruitment of Engineer Consultant (Owner's Engineer) to support DNICE and UGPE in the Implementation, Control and Supervision of the works and supplies in the scope of the Component 1 Renewable and Efficient Electricity Service (Subcomponent 1.a: Small-scale variable renewable energy integration) of the Sustainable Electricity Service Project. The total duration of this assignment is estimated in thirty-six (36) months.
