**Assignment Title: RECRUITMENT OF A CONSULTANT TO DEVELOP SYSTEM TO MONITORING STATE-OWNED ENTERPRISES**

The Government of Cabo Verde has received from the International Development Association – IDA/ World Bank (hereafter named “World Bank”), a credit to fund the state-owned enterprises related fiscal management Project (“the Project”). The objective of the Project is to strengthen State Owned Enterprises (SOE) related fiscal management and intends to apply part of the amount of said credit for: **Recruitment of a consultant to develop system to monitoring State-Owned Enterprises.**
2. The objective of this Consulting Services (“the Services”) –is to develop a platform to offer a robust, secure and scalable system, which provides electronic instruments and procedures to achieve the objectives of transparency, speed and efficiency in the follow-up of public companies. The development of the platform will improve the SOE’s fiscal management and risk assessment by expanding the functionalities of existing SOE’s database to debt held by SOEs with goals to produce timely high quality and more comprehensive operational and financial information including debt and contingent liabilities in the sector to inform decision making. The assignment is expected to take about five (05) months to complete.
