Assignment Title: Technical assistance preparation of the municipalities Urban Plans - (Plano Detalhado (PD) in the following localities: I Group - Simão Ribeiro (Praia - Santiago), Achada Leitão Baixo (São Salvador do Mundo - Santiago), Calabaceira (Ribeira Grande - Santiago) and Praia Baixo (São Domingos – Santiago)

1. The Government of Cabo Verde has received from the International Development Association – IDA / World Bank (hereafter named “World Bank”), a credit to fund the state-owned enterprises related fiscal management Project (“the Project”) and intends to apply part of the proceed for consulting services: **Technical assistance preparation of the municipalities Urban Plans (Plano Detalhado (PD) in the following localities: I Group - Simão Ribeiro (Praia - Santiago), Achada Leitão Baixo (São Salvador do Mundo - Santiago), Calabaceira (Ribeira Grande - Santiago) and Praia Baixo (São Domingos – Santiago).**

2. The objective of this Consulting Services (“the Services”) –is to contract a consulting and urban planning firm to prepare Detailed Plans (PD) provided for in the Municipal Master Plan (PDM). The DPs are intended for developing and implementing the PDMs for the structuring of land occupation and use, providing the reference framework for the enforcement of urban policies and defining the location of the main collective infrastructure and equipment. The PDs will cover areas within the municipality and included in the urban perimeter of the PDM, and also the complementary rustic lands of one or more urban perimeters, which prove to be necessary to establish an integrated planning intervention. They may also cover other areas in the municipal territory likely be intended for urban use and purposes, namely the location of industrial, logistical or service facilities or parks or the location of tourist developments and associated equipment and infrastructure. The total duration is estimated at ten (10) and a half month (9 months + 1 month for public exhibition and + 15 days for administrative proceedings of the public exhibition period) from the contract signature date.

3. The Consultants must consult the detailed Terms of Reference (TOR) for the assignment by requesting it to the addresses of e-mail given below, from 8 a.m. until 16 p.m. (local time), during the

- (i) *Core business and years in the business;*
- (ii) *Relevant experience of the Consultants for the assignment;*
- (iii) *Specific related experience in Cabo Verde or in countries with similar conditions of Cabo Verde;*
- (iv) *Technical and managerial organization of the firms;*

6. Key Experts will not be evaluated at the shortlisting stage.

The attention of interested Consultants is drawn to Section III, paragraphs, 3.14, 3.16, and 3.17 of the World Bank’s “Procurement Regulations for IPF Borrowers”, dated July 2016 and revised in November 2020 (“Procurement Regulations”), setting forth the World Bank’s policy on conflict of interest.

8. **Consultants may associate with other firms to enhance their qualifications but must indicate clearly whether the association is in the form of a joint venture and/or a sub-consultancy. In the case of a joint venture, all the partners in the joint venture shall be jointly and severally liable for the entire contract, if selected.**

9. **The Client reserve the right to not awarded more than two (2) contracts for preparation of the Urban Plan (PD - Plano Detalhado) by firms.**

10. **A consultant will be selected in accordance with the Least Cost Selection (LCS) method set out in the World Bank’s “Procurement Regulations for IPF Borrowers”, dated July 2016 and revised in November 2020.**
