**Assignment Title: Third Party Monitoring (TPM) agency of COVID-19 Vaccination and Deployment**

1. The Government of Cabo Verde signed a credit agreement with the International Development Association (IDA) of the World Bank Group for third additional funding for the project of Emergency Response to the pandemic of COVID19 in Cabo Verde aiming to prepare and respond to the pandemic of COVID19 in Cabo Verde, and intends to apply part of the amount of said credit for the Third Party Monitoring (TPM) agency of COVID-19 Vaccination and Deployment.
2. The objective of this Consulting Services (“the Services”) is to recruit an independent TPM Agency to support the Government of Cabo Verde to comply with the NCVP, World Health Organization (WHO) standards and World Bank policy and requirements reflected in the legal agreements of the Project, Environmental and Social Management Framework (ESMF) and the Project Operational Manual (POM). This will include a specific focus on supply chain management and administration of COVID-19 vaccines at (i) the key points in the supply chain and (ii) vaccination sites from the technical, environmental and social standards perspectives. This assignment is to be carried out until end of December 2021 and may be extended as needed and upon satisfactory performance.
