Assignment Title: Study for the rehabilitation of the fish market in Mindelo

1. The Government of the Republic of Cabo Verde has received from the International Development Association – IDA/ World Bank (hereafter named “World Bank”), a Credit (hereinafter called “Credit”) toward the costs of the **Resilient Tourism and Blue Economy Development in Cabo Verde Project** and intends to apply part of the proceeds for consulting services. The objective of the Project is to increase diversity and resiliency in the tourism offering and SME participation in tourism-related value chains in targeted destinations.
2. The objective of this Consulting Service (“the Service”) – is to promote sustainable development through the integration of coastal fisheries value chains (fish market and landing site) with tourism and creative industries (culture, museum), particularly sub-sectors linked to the restaurant, hotel and culture supply chains, fishing, tourism, and cultural value chains.

The assignment is expected to take about five (5) months from the date of signing the contract.

- *Specific experience in Cabo Verde or in countries with similar conditions or context of Cabo Verde;*
- *Technical and managerial organization of the firm.*
