Assignment Title: Contracting an international market representation firm to support ITCV's marketing effort in selected/prioritized European source market(s).

- 1. The Government of the Republic of Cabo Verde has received from the International Development Association IDA/ World Bank (hereafter named "World Bank"), a Credit (hereinafter called "Credit") toward the costs of the Resilient Tourism and Blue Economy Development in Cabo Verde Project and intends to apply part of the proceeds for consulting services. The objective of the Project is to increase diversity and resiliency in the tourism offering and SME participation in tourism-related value chains in targeted destinations.
- 2. The objective of this Consulting Service ("the Service") is to technical assistance are as follows:
 - ✓ Promotion and management of brand and destination awareness, boosting demand for Cabo Verde in the French and Benelux (Belgium, the Netherlands and Luxembourg) markets;
 - ✓ Continuous and growing involvement in building relationships with the travel and related services segment as well as the relationship with the media, in the market;
 - ✓ Build mechanisms to prioritise diversification that goes beyond the dominant Sun & Sea, all-inclusive model, but to attract other more sustainable niches such as nature and adventure tourism (especially hiking), cultural tourism, etc;
 - ✓ Help build the marketing capacity of ITCV staff throughout the process.

The assignment is expected to take about one year from the date of signing the contract.

- 8. Consultants may associate with other firms to enhance their qualifications but should indicate clearly whether the association is in the form of a joint venture and/or a sub-consultancy. In the case of a joint venture, all the partners in the joint venture shall be jointly and severally liable for the entire contract, if selected.
- 9. A consultant will be selected under the **Quality and Cost Based Selection** (**QCBS**) method set out in the World Bank's "Procurement Regulations for IPF Borrowers", dated November 2020.
