Assignment Title: Design of a Result – Based Management Model to be Piloted in Four Municipalities (Education Sector).

- 1. The Government of Cabo Verde has received from the International Development Association IDA / World Bank (hereafter named "World Bank"), the Credit ref. 6331-CV to fund the Education and Skills Development Enhancement Project aiming at supporting the extension of basic education from six to eight years and the establishment and operationalization of a skills development fund. The Government intends to apply part of the amount of said credits for a Technical Support to Design and Implement Performance Based Management Model to be Pilot in Four Municipalities.
- 2. The Consulting Services ("the Services") is for Design of a Result Based Management Model (RBM) to be Piloted in Four Municipalities (Education Sector). The objective of the RBM model aims to strengthen local capacity for greater autonomy in the administrative, teaching and financial management of the education system. This assignment is expected to last approximately 16 months. The pilot is expected to begin November 2020 and last for one year. The last product, the final evaluation of the pilot, is expected two months after the pilot is completed.
