Assignment Title: Development of a Socio Emotional Skills Module for Grades 7th and 8th

The Government of Cabo Verde has received from the International Development Association – IDA / World Bank (hereafter named "World Bank"), the Credit ref. 6331-CV to fund the **Education and Skills Development Enhancement Project** aiming at supporting the extension of basic education to grade 8 and the establishment and operationalization of a skills development fund and intends to apply part of the amount of said credit for: Development of a Socio Emotional Skills Module for Grades 7th and 8th.
- 2. The Consulting Services ("the Services") is for Development of a Socio Emotional Skills Module for Grades 7th and 8th. The objective of the provide 7th and 8th grades teachers with the skills and knowledge needed to help students develop appropriate socio-emotional skills, in order to help students, develop positive social relationships and responsible decision-making.
