The Government of Cabo Verde has received from the World Bank toward the cost of Social Inclusion Project, and intends to apply part of the proceeds toward payments under the contracts (Lots) for purchase of Twelve vehicles for MFIS Ministério da Família e Inclusão Social and Municipalities: **LOT I - Purchase of eleven (11) vehicles pick up; LOT II - Purchase of one (1) vehicle closed cabin,**

Bidding will be conducted through National competitive procurement using a Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers" Procurement Regulations for IPF Borrowers", dated July 2016 and revised in November 2017 ("Procurement Regulations"), and is open to all eligible Bidders as defined in the Procurement Regulations. Bidders may Bid for one or both contracts (Lot) in separate bids, as further defined in the request for bids document. Bidders wishing to offer discounts in case they are awarded more than one contract will be allowed to do so, provided those discounts are included in the Letter of Bid.
